Termination on the maturity date: On the maturity date you will receive:

- 1. if the final reference level is above the barrier level, a cash payment equal to USD 100; or
- if the final reference level is at or below the barrier level, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference level divided by (B) the strike level.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

When purchasing this product during its lifetime, the purchase price may include accrued coupon on a pro rata basis.

# 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?
