The product is designed to provide a return in the form of (1) regular fixed coupon payments and (2) a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

- 1. if the final reference level is above the barrier level, a cash payment equal to USD 100; or
- 2. if the **final reference level** is at or below the **barrier level**, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the **final reference level** divided by (B) the **strike level**.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

When purchasing this product during its lifetime, the purchase price may include accrued coupon on a pro rata basis.

The risk indicator assumes you keep the product until 6 May 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

# 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
