## 1. What is this product?

Term	The product has a fixed term and will be due on 11 February 2025.
Objectives	The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the <b>reference rate</b> and (2) repayment of the <b>product notional amount</b> on the <b>maturity date</b> . <b>Interest:</b> On each <b>interest payment date</b> you will receive an interest payment calculated by multiplying the <b>product notional amount</b> by the applicable <b>interest rate</b> and then applying the <b>day count fraction</b> to adjust this amount to reflect the length of the relevant <b>interest period</b> . 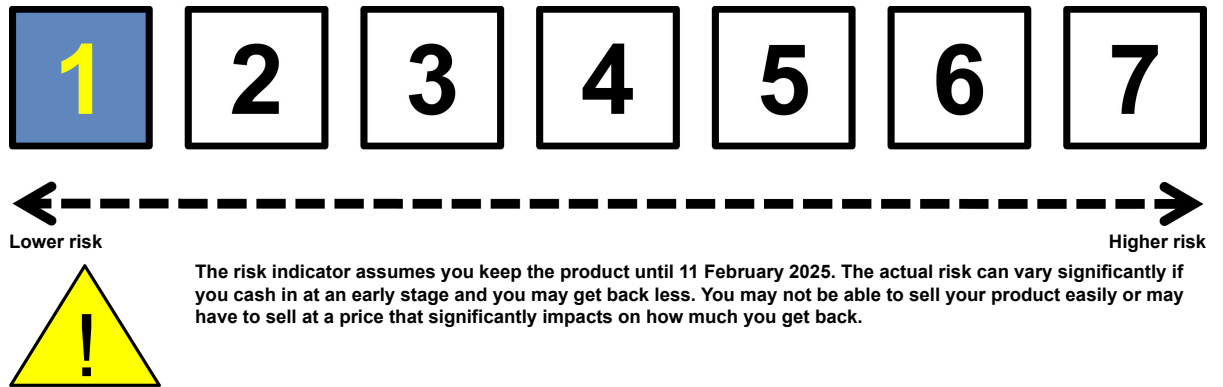

## 2. What are the risks and what could I get in return?

**Risk indicator**



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

**To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. ## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding.
