1. What is this product?

Term	The product has a fixed term and will be due on 30 June 2025.
Objectives	The product is designed to provide (1) a return in the form of variable interest payments calculated by reference to the reference rate and (2) repayment of the product notional amount on the maturity date . Interest: On each interest payment date you will receive an interest payment calculated by multiplying the product notional amount by the applicable interest rate and then applying the day count fraction to adjust this amount to reflect the length of the relevant interest period . The product is intended for private clients who pursue the objective of general capital formation / asset optimization and have a short-term investment horizon. The investor cannot bear any losses on the capital invested and attaches importance to capital protection.

2. What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until 30 June 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 5 months and 2 weeks
