1. What is this product?

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 22 December 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. 5. How long should I hold it and can I take money out early?

Recommended holding period: 8 months and 2 weeks
