## 1. What is this product?

**Type** English law governed notes / No capital protection against market risk

**Term** The product has a fixed term and will be due on 22 December 2026.

## 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 22 December 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less. ### 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?
