You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type German law governed notes / Full capital protection against market risk

Term The product has a fixed term and will be due on 14 March 2035, subject to an early redemption.

Objectives The product is designed to provide (1) a return in the form of fixed rate interest payments and (2) repayment of the **product notional amount** on termination of the product. The **product notional amount** will be repaid either (a) on the **maturity date** or (b) if we exercise our option to terminate the product prior to the **maturity date**, on the relevant **call payment date**.

(Terms that appear in **bold** in this section are described in more detail in the table(s) below.) **Early termination following a call:** We have the right to terminate the product with at least 5 business days' notice prior to each **call payment date**. In this case, the product will terminate and you will on such **call payment date** receive, in addition to a final interest payment, a cash payment equal to the call payment of USD 1,000.00. Interest rate: The interest rate for an **interest period** will depend on the number of calendar days in that **interest period** on which the **range accrual reference level** is within the **accrual range**. The interest rate will be calculated as (1) 6.10% per annum multiplied by (2) the range accrual fraction.

Range accrual fraction: The range accrual fraction for an **interest period** will be calculated as (A) the number of calendar days during the relevant **interest period** on which the **range accrual reference level** is within the **accrual range**, divided by (B) the actual number of calendar days in the relevant **interest period**.

Termination on the maturity date: If the product has not terminated early, on the **maturity date** you will receive USD 1,000.00.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

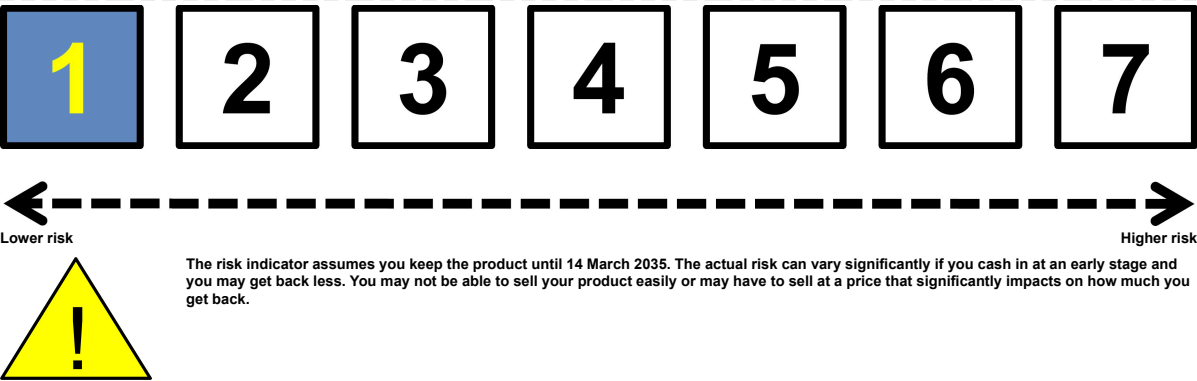

2. What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Performance scenarios

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the **reference rate** over a period of up to 5 years. 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

You are exposed to the risk that the issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. In doing so, the resolution authority has extensive intervention powers. 5. How long should I hold it and can I take money out early?

Recommended holding period: 9 years and 1 month

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 14 March 2035 (maturity), although the product may terminate early.

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
