The product has a fixed term and will be due on 1 October 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the final reference level is at or above 361.49, a cash payment directly linked to the performance of the underlying.
 The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference level divided by (B) 361.49. However, if this cash payment exceeds EUR 140, you will only receive EUR 140 (the maximum payment);
- 2. if the final reference level is at or above 271.118 and below 361.49, a cash payment equal to EUR 100; or
- 3. if the **final reference level** is below 271.118, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference level** divided by (B) 271.118.

The issuer may terminate the product with immediate effect in the event of obvious written or mathematical errors in the terms and conditions or if certain extraordinary events provided in the terms and conditions occur. Examples of extraordinary events include (1) material changes, particularly in connection with the **underlying**, including where an index ceases to be calculated, and (2) events, in particular due to changes in certain external conditions that hinder the issuer in meeting its obligations in connection with the product or – depending on the terms and conditions of the security – otherwise affect the product and/or the issuer. In case of immediate termination, the return (if any) may be significantly lower than the purchase price, but will reflect the product's market value and, if higher, any minimum redemption (alternatively, in some cases the corresponding compounded amount may be paid out at the product's scheduled maturity). We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 2 weeks
