The product has a fixed term and will be due on 10 April 2026.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- 1. if the **final reference level** is at or above the **initial reference level**, a cash payment equal to (i) EUR 100 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) EUR 200 multiplied by (ii) (x) (A) the **final reference level** divided by (B) the **initial reference level** minus (y) 100.00%. However, if this cash payment exceeds EUR 122.60, you will only receive EUR 122.60 (the maximum payment); or
- if the final reference level is below the initial reference level, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference level divided by (B) the initial reference level.

Under the product terms, certain dates specified below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 10 April 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the **underlying** over a period of up to 5 years. The stress scenario shows what you might get back in extreme market circumstances.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 1 year

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 10 April 2026 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
