The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

- if the final reference level is at or above 667.067, a cash payment directly linked to the performance of the underlying.
  The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference level divided by (B) 667.067. However, if this cash payment exceeds EUR 136, you will only receive EUR 136 (the maximum payment);
- 2. if the final reference level is at or above 400.24 and below 667.067, a cash payment equal to EUR 100; or
- 3. if the **final reference level** is below 400.24, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference level** divided by (B) 400.24.

### 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

### Recommended holding period: 4 years

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 20 November 2029 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread.
