The product has a fixed term and will be due on 6 May 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the **final reference level** is at or above 3,536.52, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) the **product notional amount** multiplied by (ii) (A) the **final reference level** divided by (B) 3,536.52. However, if this cash payment exceeds EUR 1,400, you will only receive EUR 1,400 (the maximum payment) and if it is less than EUR 1,200, you will receive EUR 1,200 (the minimum payment); or
- if the final reference level is below 3,536.52, a cash payment equal to EUR 1,000.

5. How long should I hold it and can I take money out early?
