The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.



The product is intended for private clients who pursue the objective of general capital formation / asset optimization and have a short-term investment horizon. This product is a product for clients who have sufficient knowledge and / or experience to make an informed investment decision. ## 2. What are the risks and what could I get in return?







The risk indicator assumes you keep the product until 16 March 2026. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
