The product has a fixed term and will be due on 9 January 2026.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

- if the **final reference level** is at or above 2,249.804, a cash payment equal to (i) USD 100 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) USD 200 multiplied by (ii) (x) (A) the **final reference level** divided by (B) 2,249.804 minus (y) 100.00%. <u>However, if this cash payment exceeds USD 121.40, you will only receive USD 121.40 (the maximum payment)</u>; or
- if the final reference level is below 2,249.804, a cash payment directly linked to the performance of the underlying. The
  cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference level divided by (B) 2,249.804.

## 2. What are the risks and what could I get in return?

## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?
