The product has a fixed term and will be due on 17 July 2028, subject to an early redemption.

The product is designed to provide a return in the form of (1) regular fixed coupon payments and (2) a cash payment on termination of the product. The timing and amount of this payment will depend on the performance of the **underlying**.

Early termination following an autocall: The product will terminate prior to the maturity date if, on any autocall observation date, the reference price is at or above the relevant autocall barrier price. On any such early termination, you will on the immediately following autocall payment date receive, in addition to a final coupon payment, a cash payment equal to the autocall payment of USD 100. Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive:

- 1. if the final reference price is at or above the barrier price, a cash payment equal to USD 100; or
- if the final reference price is below the barrier price, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference price divided by (B) the strike price.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

You do not have any entitlement to a dividend from the **underlying** and you have no right to any further entitlement resulting from the **underlying** (e.g., voting rights).



We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact our capacity to pay you.

#### 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

## Recommended holding period: 2 years and 10 months

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 17 July 2028 (maturity), although the product may terminate early.

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
