

SUPPLEMENT DATED 3 NOVEMBER 2022

This document constitutes a supplement (the "**Supplement**") to the prospectus, as previously supplemented by the supplement dated 5 August 2022 and the supplement dated 27 September 2022, constituted from (i) the registration document for secondary issuances of non-equity securities dated 3 May 2021, as supplemented by the first supplement dated 4 August 2021 (the "**First Supplement**"), the second supplement dated 2 November 2021 (the "**Second Supplement**"), the third supplement dated 31 January 2022 (the "**Third Supplement**"), the fourth supplement dated 16 March 2022 (the "**Fourth Supplement**") and the fifth supplement dated 2 May 2022 (the "**Fifth Supplement**"), (the "**Registration Document 2021**") and (ii) the following securities note:

Securities Note for Certificates, Warrants and Notes dated 2 December 2021, as supplemented, as approved by the *Commission de Surveillance du Secteur Financier* (the "**CSSF**") (file number C-027018)

(the "**Prospectus**"), which has been prepared by Deutsche Bank Aktiengesellschaft (the "**Issuer**") pursuant to Art. 23 (1) and Art. 23 (5) of Regulation (EU) 2017/1129 (as amended from time to time, the "**Prospectus Regulation**").

This Supplement should be read in conjunction with the Prospectus, including the documents incorporated by reference therein. The terms used in this Supplement have the same meaning as the terms used in the Prospectus.

The purpose of this Supplement is to amend the disclosure on the Issuer contained in the Prospectus following, in particular, the publication of the unaudited earnings report as of 30 September 2022 of the Issuer (the "Q3 **2022 Earnings Report**") on 26 October 2022 with information on the Issuer contained in the registration document for secondary issuances of non-equity securities dated 4 May 2022, as supplemented by the first supplement dated 3 August 2022, the second supplement dated 23 September 2022 and the third supplement dated 2 November 2022, (the "**Registration Document 2022**").

The Issuer accepts responsibility for the information contained in this Supplement (including any information incorporated by reference in the Prospectus by this Supplement). To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case), the information contained in this Supplement (including any information incorporated by reference in the Prospectus by this Supplement) is in accordance with the facts and does not omit anything likely to affect the import of such information.

This Supplement and the documents incorporated by reference in the Prospectus by this Supplement will be published in electronic form on the website of the Luxembourg Stock Exchange (www.bourse.lu) and on the website of the Issuer (www.xmarkets.db.com).

Any investor who had already agreed to purchase or subscribe for any securities to be issued pursuant to the Prospectus before this Supplement was published may, if the securities have not yet been delivered to the investor at the time when the significant new factor, material mistake or material inaccuracy referred to in Art. 23 (1) of the Prospectus Regulation arose or was noted, withdraw from its purchase or subscription pursuant to Art. 23 (2a) of the Prospectus Regulation as a result of the publication of this Supplement on or before 9 November 2022.
