The product has a fixed term and will be due on 3 March 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

- 1. if the **final reference level** is at or above 4,238.38, a cash payment equal to (i) EUR 100 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) EUR 200 multiplied by (ii) (x) (A) the **final reference level** divided by (B) 4,238.38 minus (y) 100.00%. <u>However, if this cash payment exceeds EUR 141, you will only receive EUR 141 (the maximum payment)</u>; or
- 2. if the **final reference level** is below 4,238.38, a cash payment directly linked to the performance of the **underlying**. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the **final reference level** divided by (B) 4,238.38.

Examples of extraordinary events include (1) material changes, particularly in connection with the **underlying**, including where an index ceases to be calculated, and (2) events, in particular due to changes in certain external conditions that hinder the issuer in meeting its obligations in connection with the product or – depending on the terms and conditions of the security – otherwise affect the product and/or the issuer. ### 2. What are the risks and what could I get in return?







The risk indicator assumes you keep the product until 3 March 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.
