The product has a fixed term and will be due on 9 March 2028, subject to an early redemption.

As of the date and time of production of this key information document, a corporate action has occurred on one or more of the underlyings. Please review the description below carefully to understand how this impacts the amount you may receive on the maturity date.

The product is designed to provide a return in the form of a cash payment on termination of the product. The timing and amount of this payment will depend on the performance of the underlying.

Early termination following an autocall: The product will terminate prior to the maturity date if, on any autocall observation date, the reference price is at or above the relevant autocall barrier price. On any such early termination, you will on the immediately following autocall payment date receive a cash payment equal to the applicable autocall payment. Termination on the maturity date: If the product has not terminated early, on the maturity date you will receive:

- 1 if the final reference price is at or above EUR 7.8498, a cash payment equal to EUR 159; or
- 2. if the final reference price is below EUR 7.8498, a cash payment directly linked to the performance of the underlying. The cash payment will equal (i) EUR 100 multiplied by (ii) (A) the final reference price divided by (B) EUR 13.083.

Under the product terms, certain dates specified above and below will be adjusted if the respective date is either not a business day or not a trading day (as applicable). Any adjustments may affect the return, if any, you receive.

You do not have any entitlement to a dividend from the underlying and you have no right to any further entitlement resulting from the underlying (e.g., voting rights).

2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 9 March 2028. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 3 years and 1 month

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 9 March 2028 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product either (1) through the exchange (where the product is listed) or (2) off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
