The risk indicator assumes you keep the product until 17 March 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 2 months
