1. What is this product?

The product has a fixed term and will be due on 10 February 2025.

The product is designed to provide a return in the form of a cash payment on the **maturity date**. The amount of this payment will depend on the performance of the **underlying**.

On termination of the product on the maturity date you will receive:

- if the **final reference level** is at or above 4,164, a cash payment equal to (i) USD 100 plus (ii) an amount directly linked to the performance of the **underlying**. This amount will equal (i) USD 200 multiplied by (ii) (x) (A) the **final reference level** divided by (B) 4,164 minus (y) 100.00%. <u>However, if this cash payment exceeds USD 139, you will only receive USD 139 (the maximum payment)</u>; or
- if the final reference level is below 4,164, a cash payment directly linked to the performance of the underlying. The
 cash payment will equal (i) USD 100 multiplied by (ii) (A) the final reference level divided by (B) 4,164.


The issuer may terminate the product with immediate effect in the event of obvious written or mathematical errors in the terms and conditions or if certain extraordinary events provided in the terms and conditions occur. Examples of extraordinary events include (1) material changes, particularly in connection with the **underlying**, including where an index ceases to be calculated, and (2) events, in particular due to changes in certain external conditions that hinder the issuer in meeting its obligations in connection with the product or – depending on the terms and conditions of the security – otherwise affect the product and/or the issuer. 2. What are the risks and what could I get in return?

The risk indicator assumes you keep the product until 10 February 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

To the extent the currency of the country in which you purchase this product or your account currency differs from the product currency, please be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the underlying over a period of up to 5 years. 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

5. How long should I hold it and can I take money out early?

Recommended holding period: 3 weeks and 2 days

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
