## 1. What is this product?

The risk indicator assumes you keep the product until 7 May 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

### **Recommended holding period: 1 month**
