You are about to purchase a product that is not simple and may be difficult to understand.

## 1. What is this product?

**Type** German law governed notes

**Term** The product has a fixed term and will be due on 2 July 2025.

**Objectives** The product is designed to provide (1) a return in the form of interest payments calculated by reference to the relevant interest rate and (2) repayment of the **product notional amount** on the **maturity date**.

Interest: On each **interest payment date** you will receive an interest payment calculated by multiplying the **product notional amount** by the applicable **interest rate** and then applying the **day count fraction** to adjust this amount to reflect the length of the relevant **interest period**. ## 3. What happens if Deutsche Bank AG, Frankfurt is unable to pay out?

#### 5. How long should I hold it and can I take money out early?

##### Recommended holding period: 3 months and 2 weeks

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 2 July 2025 (maturity).

The product does not guarantee the possibility to disinvest other than by selling the product off-exchange. Save as otherwise disclosed in exit costs (see section "4. What are the costs?" above), no fees or penalties will be charged by the issuer for any such transaction. However if you sell the product in the secondary market you will incur a bid/offer spread. By selling the product before its maturity, you may receive back less than you would have received if you had kept the product until maturity.
